#### **Course Description:**

This introductory course is designed to help students better understand the variables of substance abuse, dependence, prevention, intervention and treatment. This course will look at the effects of substance abuse on individuals, families and groups. Students will develop an understanding of the knowledge, skills and attitudes necessary for effective treatment approaches as well as the multi-faceted aspects associated with drugs/alcohol use, abuse and dependence.

Additionally this course will help students gain an understanding of struggles associated with the addict and further understand complications as they relate to interventions. Lastly, the student will indentify and clarify their personal biases, viewpoints, opinions, and perspectives in regards to drugs abuse and dependence.

#### **Learning Outcomes:**

The primary goal of SW 2280 is to provide the student an educational experience in understanding the dynamics underlying use, abuse and addiction as well as an introduction into the various treatment modalities available for this population. The instructor will facilitate and create an environment that will ensure the safe disclosure of thoughts, ideas, and personal opinions regarding the material.

The learning experience will depend heavily on the commitment of the student to be prepared to participate in classroom discussions, exercises and activities. Attendance and participation is expected and crucial to your learning.
