Review of 2020-21 Recommendations

Charge for 2021-2022

As the strategy lead, please accomplish the following items:

- 1. Implement ScholarshipUniverse (Award Spring replacement)
- 2. Continue translation of Admissions/Marketing/Recruitment Materials into Spanish
- 3. Build out PLA (technology, personnel, etc.)
- 4. Develop and implement a recruitment and strategic enrollment management plan to support growth in the following areas: Adult Students (first-time and some college), Male Students, and West Side (collaborate with Jen Seltzer Stitt and Idolina Quijada, co-leads on the Strategy #8 CWT).
- 5. Analyze the impact of federal, state, and college funds on enrollment, retention and completion (i.e. New Student Scholarship was it effective and what results did it produce). The goal here is to determine if we are "pulling the right levers" with financial aid to increase college enrollment.
- 6. Work with DSA to lead conversations and communicate findings on the causes of the decline in higher education participation. This may include a Provost's forum, SLCC 360 presentation, town hall-style meeting, or other event.

Presenting and Reporting

You will be asked to present updates at planning council, senior leadership team, or cabinet meetings. You will also meet with me and the president periodically to discuss strategy progress. We will discuss any presentation preparation needs once dates and topics are set.

At the conclusion of the year, you will need to provide a short, written report on the work accomplished. This report will be submitted to Vice President Aird on May 1, 2022.
