# **Abstract**

Salt Lake Community College (previously known as Salt Lake Area Vocational School [SLAV] 1948-1959, Salt Lake Trade Technical Institute [SLTTI] 1959-1967, Utah Technical College [UTC] 1967-1987) is a Community College with roots in vocational programs which have expanded over the years to include programs, degrees, certificates, and diplomas in other disciplines. The Administrative Units Fonds consists primarily of textual materials, photographic materials, and audiovisual materials related to various administrative units in the College and their tasks.

# Historical Sketch of Salt Lake Community College, 1948-

Salt Lake Community College began teaching classes September 14, 1948 as the Salt Lake Area Vocational School. A product of the GI Bill, the school evolved out of the War Production Training School established at West High School during World War II. After most federal support dried up in 1946, the Salt Lake City School District continued funding the program on its own, which was a burden for the district. The district, along with the State Board of Vocational Education, the Salt Lake Chamber of Commerce, the local American Legion, and Veterans of Foreign Wars successfully lobbied the state legislature to create state-supported vocational schools. On 19 March 1947, money was appropriated for establishing vocational schools in all school districts serving populations of at least 140,000.

The Salt Lake City School Board selected long-time vocational teacher Howard Gundersen as the school's first president. The old Troy Laundry Building on 461 South 600 East in Salt Lake City was selected as the school's first building, and equipment was donated from Salt Lake area high schools which had housed War Production Training Schools. Gundersen received authorization from the Salt Lake City, Park City, and Tooele School districts to teach 39 vocational programs, although teachers could not be found for all of them immediately.

Newspaper ads for the school carried the slogan "Learn to Earn," which would be used into the 1970s. In its first quarter, tuition for the school was \$78 annually, and 246 students registered in 14 classes. By the following quarter, 948 students were enrolled, including 589 veterans.

In 1949, J. Bracken Lee became governor of Utah. A fiscal conservative, he opposed the Area Vocational School, believing it duplicated services available elsewhere. When the legislature presented the 1949–1950 budget with expenses projected to exceed revenues by \$2 million, Lee used line-item vetoes to cut the entire \$500,000 appropriated to the school. Lee's veto drew criticism from The Salt Lake Tribune, labor unions, and veterans' organizations, but the supporters of the cut stood firm, alleging wastefulness at the school. Only by scaling back operations to \$145,000 annually was Gundersen able to keep the school open.

The second President of the school, Jay L. Nelson (1949–1978), referred to the first years of Lee's governorship as "the starvation years". No state funding was provided to the school again until 1951, when it began receiving modest subsidies, and a \$312,000 grant to purchase the Troy Laundry Building.

Initially the school was seen as a central location for high school vocational education, and the school was thus an extension of public secondary education. The school was guided jointly under the direction of the state and local school board until 1959. At this time, it changed its name to Salt Lake Trade Technical Institute, reflecting the more adult-oriented nature of the school. Governance for the school moved solely into the state's hands under the State Board for Vocational Education.

In 1967 most departments of the school (now renamed Utah Technical College at Salt Lake) moved to the current location at 4600 South Redwood Road in what is now Taylorsville. The state legislature

granted money for expansion at the Taylorsville Redwood campus, which is now the primary campus of SLCC. A thriving vocational program existed at the original site well into the 1980s that served thousands of students seeking basic education and occupational skills.

In 1969 the State unified the scattered public higher education direction into the State Board of Higher Education (later called the Board of Regents). However, the Technical College was not placed entirely under this board. Instead, it was jointly governed by the State Board of Higher Education and the State Board of Vocational Education. Turf wars between the boards erupted almost immediately in 1970 and again in 1974 when the boards fought over who had authority to raise salaries (it was decided that the vocational board controlled wages, but that the higher education board dictated budgets). The Board of Higher Education first sought to convert the schools into community colleges in 1970, which the vocational board outright rejected. The Vocational Board eventually relinquished control of the school in 1978 with an agreement that technical school maintain 75% vocational training, which was state law at the time. President Jay L. Nelson believed this was necessary to prevent the school from becoming merely a feeder for the University of Utah. However, in 1987 the school formally became Salt Lake Community College and the old requirement 75% for vocational training ended.

As of 2023, Salt Lake Community College is the largest two-year college in Utah, serving over 45,000 students across ten campuses. Notably, South City Campus opened in 1991, Miller Campus in 1999, SLCC Online (an eCampus) in 1999, Jordan Campus in 2001, and the West Valley Center in 2015. SLCC is accredited by the Northwest Commission on Colleges and Universities, and offers 120 programs of study. Its mission statement emphasizes a "commit[ment] to the transfer education and workforce needs of [the] students."

# Scope and Content of the Administrative Units Fonds

Salt Lake Community College (previously known as Salt Lake Area Vocational School [SLAV] 1948-1959, Salt Lake Trade Technical Institute [SLTTI] 1959-1967, Utah Technical College [UTC] 1967-1987) is a Community College with roots in vocational programs which have expanded over the years to include programs, degrees, certificates, and diplomas in other disciplines. This collection includes textual, photographic, and audiovisual materials, as well as artefacts, created by the College, individuals associated with the College, and related entities between 1948 to current day. The Administrative Fonds is divided into thirteen series.

# Series 1:

Accreditation and Self Study are records created both College entities and accrediting bodies. These records document the College's ongoing efforts to maintain standards through accreditation of programs and overall offerings. The series is divided into three subseries:

- Subseries A: Accreditation houses records related to external accreditation of the College and its programs.
- Subseries B: Self-Study houses records pertaining to the College's internal efforts to improve offerings. Note that self-studies and self-evaluations are often informed by handbooks from external agencies, and follow procedures established outwith the College.
- Subseries C: Masterplans houses records documenting the College's plans and goals for itself.

Records in these series include steering committee notes and minutes, reports, handbooks, and correspondence. There are also CDs with digital versions of the reports. Included in this series are 10.83 linear feet of textual records and 1 linear inch of CDs.

# Series 2:

College Annual Reports are records created by the College regarding various aspects of the College, such as state of the college reports, financial and budget reports, departmental reports, and reports for the Utah state legislature. Included in this series are 1.56 linear feet of textual records.

# Series 3:

College Surveys are records created by various College departments. These records include focus groups, qualitative surveys/audits and records not found in Series 1. The series contains two subseries:

- **Subseries A: Assessment** contains surveys and studies conducted to gather information on the different ways the College performs assessment.
- Subseries B: Follow-up Surveys contains the results of surveys of different groups
  associated with the College, namely students and employers. These surveys usually
  contain results for the groups of graduating student; returning student; non-returning
  student; and employer. In later years, the results of all four groups are bound together
  into one volume.

Records in this series include reports, correspondence such as memos, and small bound volumes. Included in this series are 2.17 linear feet of textual records.

# Series 4:

Board of Regents are records created by the Board of Regents, a State board which has governance responsibilities regarding the College, that document the actions of the Board. Included in this series are 16.25 linear feet of textual records, such as meeting minutes, correspondence, and reports.

# Series 5:

Board of Trustees are records created by the Board of Trustees for the College that document the meetings and decisions of the group. Throughout the history of the College, the Board has existed to assist with the management of the College. The Board has had various names over the years, as follows: The Salt Lake Area Vocational School Board from 1947-1959; the Salt Lake Trade Technical Institute Advisory Committee from 1959-1967; the Utah Technical College at Salt Lake Advisory Committee from 1967-1978; the Utah Technical College at Salt Lake Institutional Council from 1978-1987; the Salt Lake Community College Institutional Council from 1987-1991; and the Salt Lake Community College Board of Trustees from 1992 through the present. This series houses the records of this group under all these titles. Starting in October 2008, audio recordings of the meetings were saved on CDs, which are filed separately from the meeting papers. Included in this series are 11.88 linear feet of textual records and 1.13 linear feet of audiovisual materials on CD and DVD.

# Series 6:

Committees are records created by various committees conducting the College's business or initiatives. The series has three subseries:

- Subseries A: College Advisory Committee Papers houses the records related to the numerous Advisory Committees supporting College departments. Note: Although 'Advisory Committee' and 'Advisory Council' are used interchangeably in these papers, they should not be confused with the Advisory Council which was later renamed the Board of Trustees. These committees advised on departmental affairs, not College-wide interests.
- Subseries B: Program Advisory Committee Papers houses records created by the Program Advisory Committees. These committees worked closely with the departmental Advisory Committees, and often created reports which were sent to the Advisory Committees.
- Subseries C: Semester Conversion houses the records of the committee tasked with overseeing the transition from quarters to semesters.

Records which do not fit into these subseries are arranged chronologically. Included in this series are 6.88 linear feet of textual records.

# Series 7:

Faculty and Staff Associations are records created by members of faculty and staff professional groups which document their work and support of College employees. Included in this series are 2.50 linear feet of textual records and one CD.

### Series 8:

Faculty Senate are records created the College Faculty Senate and its committees, and which document that body's work to liaise with administration and assist in the governance of the College. Originally called the College Senate, the name of the group changed to the College Faculty Senate in 1990. Included in this series are 0.93 linear feet of textual records.

# Series 9:

Institutional Advancement are records created the Institutional Advancement office which document the College's self-promotion. These records include marketing, audiovisual, and other materials. Included in this series are 0.31 linear feet of textual records.

### Series 10:

College Legal and Constituting Documents are records created by College administration which document the College's legal standing. Included in this series are 0.13 linear feet of textual records.

# Series 11:

Presidents' Tenure are records created by the Office of the President or by other parties which document the work of the President of the College. These papers include speeches and addresses, correspondence, photographs, reports, and articles created during each College President's Tenure. Personal research of the Presidents, where related to the College, is also included in this series. The series is divided into subseries, each corresponding to a President and their tenure:

- Subseries A: Howard B. Gunderson (Founding President 1948-1949)
- **Subseries B:** Jay L. Nelson (President 1949-1978):
  - Note: The Physical Archives contains President Nelson's papers, as well as papers which were written by Jay L. Nelson but donated by Bruce Nelson.

- Subseries D: James R. Schnirel (Interim President 1980-1981)
- Subseries E: Orville D. Carnahan (President 1981-1990)

- Subseries H: H. Lynn Cundiff (President 2000-2003)
- Subseries I: Judd Morgan (Interim President 2003-05)
- Subseries J: Cynthia Bioteau (President 2006-2013)
- Subseries K: Deneece Huftalin (Interim President 2013-14, President 2014-)

Each series houses the papers of a President. Included in this series are 22.51 linear feet of textual materials, 2 linear inches of audiovisual materials on CD and DVD, 6.25 linear inches of photographic slides, and 1.08 linear feet of artefacts.

Student Government are records created by the student governing body and which document the activities of the student government and its members. Included in this series are 0.10 linear feet of textual records.

# Series 13:

Photograph Materials are records created by various administrative units at the College. These photographs document activities and personnel involved in College functions. Included in this series are 1.0 linear feet of photographic materials.
