- 3. I affirm my high school transcript states that I have completed my sophomore year in high school prior to participating the CE Summer Academy Program, or that I am entering my senior year in Fall 2024. I acknowledge, understand, and agree that I may be requested to provide documentation affirming as such, and if I fail to do so after a request is made, I will be dropped and removed from participation in the program.
- 4. I acknowledge, understand, and agree that I will be responsible for all textbook costs, course fees, and other required costs associated with the participation in the class. This cost is in addition to the five dollar (\$5.00) credit tuition for cost of participation in the Program.
- 5. I understand that I may only take one (1) class through the CE Summer Academy Program per year.
- 6. I agree that I will attend every class and will notify my instructor if I cannot attend due to an unexpected medical or family emergency.
- 7. I understand that eight (8) week college classes can be intense in terms of the amount of content condensed in a shorter period of time, and I am prepared to invest the time and commitment necessary to be successful.
