Subject: Instructions - SLCC Tuition Waivers for SkillsUSA Winners

Congratulations! You are ***eligible to apply*** for a SLCC SkillsUSA tuition waiver. The waiver is for full or partial tuition for Fall 2017 and/or Spring 2018 Semesters, dependent on your placement at the State competition.

- First Place – 2 semester tuition waiver (Summer semester does not apply)
- Second Place – 1 semester tuition waiver
- Third Place – 1/2 semester tuition waiver

The following procedures must be completed:

1. Apply for admission to SLCC and be accepted.
2. Declare a CTE major. (See back side of waiver form for eligible majors.)
3. Go to www.fafsa.ed.gov and fill out a FAFSA 2017-2018 form.
4. Register for courses as a matriculated student with a minimum of 12 credit hours.
5. Register for courses that relate to your major. If you have registration questions, please contact SLCC Academic Advising at 801-957-4298.
6. Call 801-957-5008 or e-mail judy.calder@slcc.edu to verify that you meet all waiver requirements. Your tuition waiver will not be activated without this notification.
7. ***Complete and return the attached waiver application form April 1, 2017 – August 14, 2017. Application review will begin August 1, 2016.***

We will review your records to verify that you meet all requirements. If you receive a tuition waiver, the Financial Aid Office will notify you by e-mail through your MyPage account.

*Apprenticeship and Continuing Education programs are ***not eligible*** for a SkillsUSA tuition waiver.

*Student fees and books are ***not*** paid for by tuition waivers.

To continue your tuition waiver for Spring Semester 2018, you must:

1. Receive a passing grade of “C” or better in a minimum of 12 credits for Fall semester.
2. Register for Spring Semester with a minimum of 12 credit hours.
3. Tuition waivers cover tuition only for 12-18 credit hours.
4. If you receive a 2 semester waiver, please notify Judy Calder of your interest to continue your tuition waiver. If you have any questions, please contact our office 801-957-5008.
